MEMBERSHIP

WHEREAS: All Christians have a responsibility to seek the justice of God's kingdom, restoring

the temporal order and directing it to God through Christ; and,

WHEREAS: The Catechism of the Catholic Church teaches that it is morally necessary to exercise

the right to vote, to defend one's country, and to offer prayers for all who exercise

authority; and,

WHEREAS: The Church affirms that democracy is the best expression of the direct participation

of citizens in political choices; and,

WHEREAS: The United States Conference of Catholic Bishops reminds all Americans, that

responsible citizenship is a virtue; and,

WHEREAS: The Knights of Columbus has a long history of encouraging its membership and

others to act on their duty of responsible and faithful citizenship;

NOW, THEREFORE, BE IT RESOLVED:

That we rededicate ourselves to our founding principles of Charity, Unity, Fraternity and Patriotism in all of our interactions with others so that we may conduct ourselves according to Our Lord's commandment that we love our neighbors as ourselves, for he said, "This is how all will know that you are my disciples, if you have love for one another" (John 13:35), and be it,

FURTHER RESOLVED:

That we will seek to build upon past efforts and programs designed to educate fellow citizens of their duties of faithful citizenship, and in a non-partisan way to help fellow Knights and other citizens to participate fully in the political process; and be it,

FURTHER RESOLVED:

That the Knights of Columbus membership of the State of Alabama meeting on April 27, 2019 in Birmingham, Alabama hereby petitions the Supreme Council of the Knights of Columbus to hereby adopt this resolution.

Article 8

Assessments

Section 1. Assessments:

An assessment on the membership of the Councils as shown by the Supreme Secretary's records shall be in the amount of seven (\$7.00) dollars eight (\$8.00) dollars per member per fraternal year. One-half of the said assessment shall be paid no later than September 1st based on membership as shown by the Supreme Secretary's records of July 1st the other one-half shall be paid no later than March 1st based on membership as shown by the Supreme Secretary's records of January 1st excepted from said assessments are the clergy, religious, disabled, life and honorary members.

Section 2. Failure to pay assessments:

- (a) Councils not having paid duly levied assessments of the Supreme and or State Council shall not have the names of their delegates placed on the permanent roll of the annual state meeting until the same is paid.
- (b) The suspension of Councils not having paid duly levied assessments within three months and ten days will be sought through section 157(8), Constitution and By Laws of the Knights of Columbus.

Article 9

Management of Funds

Section 1. Deposit of monies:

- (a) All monies of the general fund of the State Council shall be deposited in one general account in the name of the Alabama State Council, Knights of Columbus, in a depository to be selected by a majority of the state officers, except as described in subsection (b).
- (b) On or before the first Tuesday in September of each calendar year, any amount in the general fund in excess of the budgeted yearly amount from the previous year shall be deposited into an interest bearing account for disbursement called the Contingency Fund up to the maximum balance established for this fund. If the Contingency Fund is fully funded, these excess funds shall be used to support the Priesthood Scholarship Fund. Details regarding the use of the Contingency Fund are specified in article 9, section 6.

Section 2. Records of funds:

A separate record of all funds and funds including the Joseph D. O'Gara Memorial Priesthood Scholarship Fund shall be kept and these funds shall be kept on deposit in the name of the Knights of Columbus, Alabama State Council, in a financial institution and including a trust or agency department thereof, paying the highest net rate of interest and which is or are secured by instruments of agreement and insurable governing agencies thereof, and only up to the amount that is secured, as approved by a majority of the State officers or a delegated representative thereof, as elected or appointed. Any and all disbursements from the General Fund must have the approval of the Alabama State Council in accordance with Article 7, Section 9. Monies from the Joseph D. O'Gara Memorial Priesthood Scholarship Fund shall be disbursed in accordance with Article 9, Section 6. The State Treasurer will report the income and
