BYLAWS

The committee reviewed three changes to the bylaws. All changes were unanimously agreed upon by the committee, and the adoption of these changes is recommended.

In Article 5, Section 1, titles of current State Directors were updated to reflect the current offices. The Council, Youth and Culture of Life Director titles were removed as these offices no longer exist. The word Family was removed from the Life Director's title.

In Article 9, Section 2 a typographical error was corrected. A reference to the Priesthood Scholarship Fund called out Article 9, Section 6. This should have been Article 9, Section 5.

Article 9, Section 6 was rewritten. The verbiage for the Contingency Fund was replaced with verbiage for the Charity Fund. This necessitated an update to Article 9, Section 1b, where the Contingency Fund reference was replaced with the Charity Fund reference.
